## Improved Productivity and Usability

Several enhancements and features have been introduced to improve productivity and usability as follows:

- A flexible metamodel framework has been introduced. This framework helps organizations to create various semantic that enable establishing a robust data governance framework.
- The capability to create semantic associations and relationships between various business and technical assets has been added. This facilitates a meaningful landscape for business and IT.
- Workflow integration for all custom business assets is now possible.
- The capability to import or export custom business assets through MS-Excel has been introduced.

- The ability to execute the ELN engine at the metadata system and environment level for better accuracy and matching has been added.
- The 2000 object limitation with metadata scanning has been resolved.
- An enterprise-sensitive data dashboard has been introduced. This enables you to:
  - view sensitive attributes across all systems, with the ability to drill down.
  - export information to a report layout.

## Enhanced Mind Map

Mind Map has been enhanced to display all associations and relationships between business and technical assets in a dynamic layout. The new Mind Map lets you:

- expand asset or attribute nodes dynamically.
- filter mind map diagram based on asset types and relationships.

## Enhanced Business Glossary Manager UI

The Business Glossary Manager's home screen UI has been revamped to have a business-friendly layout that includes:

- a compact view for all custom asset types.
- custom or flexible views that enable you to create your own views with relevant and filtered data sets.

## Improved Security

## New Metadata Scanners

erwin DIS now supports new metadata scanners for Snowflake and Google BigQuery.

## Enhancements

Apart from the new features several enhancements have been introduced to improve productivity and usability as follows:

- Custom properties format in the Business Glossary Manager has been standardized.
- Based on user permissions, edit mode is now accessible on clicking a business term in the list of business terms.
- Labels of default attributes can now be customized (For example, name and description for asset types).
- Classification and Meaning Category Type fields are now configurable and can be turned off.
- Stewardship Goals is now configurable and can be disabled.
